
Dear CON Board:

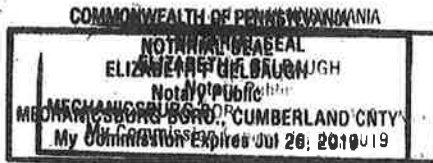
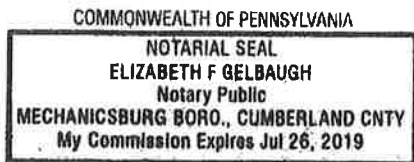


