**Re: Hanceville Nursing and Rehab Center, Inc. ("Hanceville")
Non-Reviewability Determination Request**

Dear Ms. Marsal,

Pursuant to 410-1-7-02 of the CON Program Rules and Regulations (the "Regulations"), I am writing to request your determination that Hanceville's proposed expansion project and provision of outpatient physical therapy services is not subject to certificate of need review. This letter will supplement and replace the letter I previously filed with SHPDA on March 25, 2021.

Hanceville operates a 208- bed skilled nursing home in Cullman County, Alabama at 420 Main Street NE, Hanceville, AL 35077. Hanceville proposes to build a new wing for its existing facility called "The Suites". This new wing will not change the number of Hanceville's licensed nursing home beds or its current CON for 208 nursing home beds.

In addition to skilled nursing services, Hanceville currently provides a full range of inpatient rehabilitation therapy services to its residents. In connection with the "Suites" expansion project described above, Hanceville proposes to begin providing physical therapy services on an outpatient basis. Hanceville will only provide physical therapy services (not occupational or speech therapy services) on an outpatient basis.

Hanceville will not add any new beds, provide any new health services, convert any beds from one classification to another classification, or make any expenditures in excess of the applicable spending thresholds under Ala. Code 22-21-263(a)(2) and 410-1-4-.01(1)(b) of the Regulations in connection with its "Suites" expansion project and the offering of outpatient physical therapy services. Specifically, Hanceville anticipates the cost to provide outpatient physical therapy services and complete the "Suites" expansion project to be as follows:

Capital/Construction -	\$4,500,000
Equipment -	\$12,000
New First Year Annual Operating -	\$678,950

No other healthcare facility or group has a financial interest in Hanceville.




