The organization has not been in a position to provide services over the past 12 months but is presently setting up a program to provide Home Health services to Greene County.

This request is made without a fee as pursuant to 410-1-7-.02 - Rural hospitals shall be exempt from the payment of fees under this chapter to the extent provided in ALA. CODE § 22-21-265 (1975, as amended). Greene County Hospital & Nursing Home dba Greene County Health System is designated as a rural hospital. It is in a 100% rural area (647 square miles) with no part of the county designated as urban.

There will be no equipment purchases or capital cost as the services will be provided from the hospital and the equipment is already onsite. There are no other facilities or groups that hold a financial interest in the organization.

The first-year operating cost is estimated to be \$365,000.00.
