Dear Mrs. Marsal

I am writing on behalf of Jackson Hospital and Clinic located at 1725 Pine Street, Montgomery, AL to request a determination for the need to file for a certificate of need (CON) to continue to operate the established Monoclonal Antibody Clinic located at 2024 Chestnut Street in Montgomery Alabama. This location opened under waver TW2021-031 filed on September 16<sup>th</sup> of this year.

The Monoclonal Antibody Infusion Clinic is a joint effort with Jackson Hospital and Clinic and KPMG a Federal Government Contractor providing support for The Health Equity Initiative. This clinic currently operates 5 days each week and 8 hours each day running up to 6 infusion chairs solely providing monoclonal antibody therapy to COVID-19 Patients. It does not provide for any additional hospital beds or treatments space other than the infusion of Monoclonal Antibody Therapy for COVID-19 positive patients. Per the terms of the agreement between KPMG, HHS, and Jackson Hospital and Clinic operations will cease no later than February 28<sup>th</sup>, 2022, unless otherwise extended by HHS

The Capital expense have been incurred under the under the previous waver and alternate site of care approval. The initial capital expense totaled 65 thousand dollars and monthly operating cost of 70 thousand dollar. There project does not involve additional construction, development, acquisition, or establishment of additional healthcare services. It will not result in a change of the existing hospital licensed inpatient bed capacity. It will provide for the safe and efficient infusion of monoclonal antibodies in a suite isolated from other patients with easy parking and access for COVID-19 Positive patients. No other health care facility or group holds financial interest in Jackson Hospital and Clinic inc or this project.

Payment of the \$1,000 filing fee will be made e via the SHPDA electronic Payment Portal.

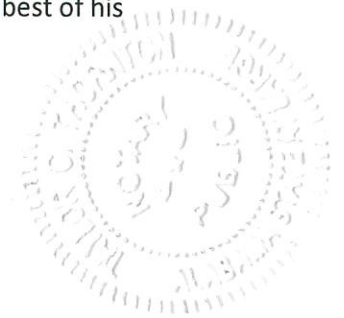


