*The Sterilization Processing Department will occupy approximately 780 sf of space on the First Floor currently occupied by maintenance personnel.
The Recover Suite will occupy approximately 2,690 sf of space on the Second Floor currently occupied by recovery and executive administration.*
4. The new/additional services are as follows:
*Sterilization will be centralized and the capacity will be increased.
The Recover Suite will expand from 7 beds to 12 beds. A second nurse station will be added and the two restrooms will be accessible.*

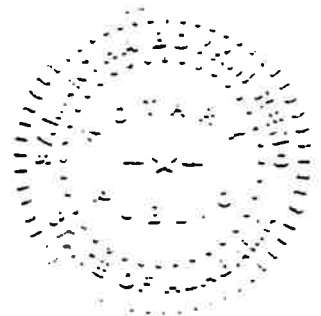

Please see the additional information requested on December 13, 2021.

1. Provide clarification as to the entirety of the healthcare services currently offered by Outpatient Care Center. If the agency is unaware of the full scope of services being provided, it cannot be determined if a CON is currently required regardless of if additional or new services will be provided.

The original CON was issued 11/12/1982 in which I do not have the original document. Outpatient Care Center is a multi-specialty surgery center that provides services in the following specialties: General Surgery, Gynecology, Ophthalmology, Orthopedic Surgery, ENT, Pain Management, Plastic Surgery, Podiatry, and Spine Surgery. The renovations are to expand the Sterilization and Decontamination department to improve workflow and throughput. The additional recovery bays are being added to accommodate 6 additional phase II recovery patients to improve patient flow. There is no plan to provide new or additional services.

2. Provide clarification as to the service area for the proposed project. ALA. ADMIN.CODE r. 410-1-2-03 defines the service area as the county in which the service will be provided in the absence of a designated geographical service area.
