AL2014-009-E, Rainbow Omega, Inc. d/b/a Strickland/Stringfellow ICF/MR, Eastaboga, AL:** This application was filed for an Emergency Certificate of Need to convert an existing ten (10) bed group home into a ten (10) bed Intermediate Care Facility/Mental Retardation. CON 2655-ICF/MR-E issued 11/15/2013. This is being presented to the Certificate of Need Board for ratification. **Opposition: Department of Mental Health filed a letter opposing the project.**

**B. AL2014-010-E, Thomasville Regional Medical Center, LLC, Thomasville, AL:** This application was filed for an Emergency Certificate of Need to construct and operate a twenty-nine (29) bed acute care hospital in the City of Thomasville, Clarke County, Alabama. CON 2656-H-E issued 12/3/2013. This is being presented to the Certificate of Need Board for ratification. **Clarke County Healthcare, L.L.C. filed a letter of intervention.**

**C. AL2013-069, Robertsdale Nursing Home, Inc. d/b/a Robertsdale Rehabilitation and Healthcare Center, Robertsdale, AL:** Proposes to add outpatient therapy services to include respiratory, physical, speech and occupational therapies. **Opposition: None**

**D. AL2013-072, Wilcox Health & Rehab Center, LLC, Camden, AL:** Proposes to add speech and occupational therapies to the existing outpatient physical therapy services. **Opposition: None**
