A. Declaratory Ruling 148:

WITHDRAWN NOVEMBER 17, 2015

Providence Hospital has submitted a Petition for Declaratory Ruling, requesting that the CON Review Board declare that Infirmity Health System, Inc. is operating a new diagnostic and imaging center in the western portion of Mobile, Alabama without first obtaining the necessary Certificate of Need from the Alabama Health Planning and Development Agency in violation of § 410-1-4-.01 of the CON Rules and *Alabama Code* §§ 22-21-263 and 22-21-265. **Infirmity Health System filed opposition to the Petition for Declaratory Ruling.**
