The Administrative Law Judge **approved** the project.

AL2018-005, Bay Eyes Surgery Center, Inc., Fairhope, AL: Proposes to add one (1) Class-C operating room, renovate existing operating rooms, upgrade one (1) procedure room to a Class-C operating room, and expand the existing ambulatory surgical services from ophthalmology only to include other surgical specialties. At the conclusion of the proposal, the facility will operate four (4) Class-C operating rooms and expand its ambulatory surgery services from single-specialty to include multiple specialties.

A. AL2018-026, DVA Healthcare Renal Care, Inc. d/b/a Ozark Dialysis, Ozark, AL: Proposes to add six (6) new in-center hemodialysis stations to the existing ESRD facility consisting of twelve (12) in-center hemodialysis stations, and one (1) hemodialysis isolation station. **Opposition: None**

B. AL2018-027, The Health Care Authority of the City of Huntsville d/b/a Huntsville Hospital, Huntsville, AL: Proposes to construct a new freestanding bed tower attached to the main hospital via a pedestrian bridge. The bed tower will

accommodate twenty-four (24) additional operating rooms, shelled in space for future use and the conversion of semi-private beds to private beds. **Opposition: None**

- C. **AL2018-028, Board of Trustees of the University of Alabama for the University of Alabama Hospital, Birmingham, AL:** Proposes to build out shell space on the 8th floor of the Women's & Infant's Center, resulting in the development of two (2) new nursing units with fifty-nine (59) total private rooms. Twenty-nine (29) private patient rooms are for the Blood and Marrow Transplant and Cell Therapy Service and thirty (30) private patient rooms are for a new inpatient acute care unit in the remaining space on the eighth floor. **Opposition: None**
- D. **Intervention/Opposition and Request for a Contested Case Hearing withdrawn, August 2, 2018. This project is Remanded to the CONRB by ALJ, Stan McDonald, filed August 8, 2018.**

AL2017-031, Physicians Choice Dialysis of Montgomery, LLC d/b/a Montgomery Community Dialysis, Montgomery, AL: Proposes to establish a new End Stage Renal Disease (“ESRD”) dialysis treatment center consisting of ten (10) in-center hemodialysis stations. **Opposition: Renal Treatment Centers – Southeast, LP d/b/a Monarch Dialysis withdrew Intervention and Opposition, filed September 8, 2017, and Request for Contested Case Proceeding, filed September 19, 2017.**

- E. **Intervention/Opposition and Request for a Contested Case Hearing withdrawn, August 6, 2018. This project is Remanded to the CONRB by ALJ, Stan McDonald, filed August 8, 2018.**

AL2017-041, Physicians Choice Dialysis of Alabama, LLC d/b/a PDI East Montgomery Dialysis, Montgomery, AL: Proposes to relocate and expand its existing thirteen (13) in-center station End Stage Renal Disease (“ESRD”) facility to a nearby location from its current center and add one (1) separately licensed isolation station for a total of fourteen (14) stations, one of which will be an isolation station. **Opposition: Physicians Choice Dialysis of Montgomery, LLC d/b/a Montgomery Community Dialysis withdrew Intervention and Opposition, filed October 10, 2017 and Request for a Contested Case Proceeding, filed October 20, 2017.**
