The next four (4) projects have been put on the agenda for **informational purposes only**. No vote is required because, "the recommended order of the Administrative Law Judge becomes the final order of the Agency when no exceptions have been filed." No exceptions were filed. The Administrative Law Judge **approved** the projects as part of a settlement agreement between parties.

**Contested Case**

**AL2018-018, LC Big Cove, LLC, Hampton Cove, AL:** Proposes to add twenty (20) new specialty care assisted living facility beds to the existing facility for a total of thirty-two (32) SCALF beds, twelve (12) of which had a Certificate of Need issued October 12, 2017 in Madison County. The ALJ approved this project for twenty (20) new SCALF beds as part of the Settlement Agreement.

**AL2018-023, Huntsville Senior Services, LLC, d/b/a Regency Remembrances, Huntsville, AL:** Proposes to repurpose an existing facility for specialty care assisted living services for eight (8) additional beds to be added to the existing SCALF service. The ALJ approved this project for the repurpose of an existing facility and the addition of eight (8) new SCALF beds as part of the Settlement Agreement.

**AL2018-024, Dominion Holdings II, LLC, d/b/a Dominion Partners, LLC, Huntsville, AL:** Proposes to construct and operate a new thirty-two (32) bed Specialty Care Assisted Living Facility, that will be part of a new continuum of care senior living community development. The ALJ approved this project for the construction and operation of a new thirty-two (32) bed SCALF as part of the Settlement Agreement.

**AL2018-025, Shepherd Living at the Range, LLC, Huntsville, AL:** Proposes to add eighteen (18) specialty care assisted living beds through new construction of a senior retirement community, for a total of forty-two (42) SCALF beds, twenty-four (24) of which had Certificates of Need issued October 12, 2017 and February 20, 2018. The ALJ approved this project for the addition of eighteen (18) SCALF beds as part of the Settlement Agreement.

VI. CERTIFICATE OF NEED PROGRAM

- A. Reconsideration: Carried over from the September 19, 2018 CONRB meeting**  
**AL2018-005, Bay Eyes Surgery Center, Inc., Fairhope, AL:** Proposes to add one (1) Class-C operating room to the existing two (2) Class-C operating rooms, convert space to a Class-C OR for a total of four (4) Class-C OR's and change the current designation as a single-specialty ambulatory surgery center to a multi-specialty ASC. This project was heard by Administrative Law Judge Mike Cole in a Contested Case Hearing. The ALJ approved the project.  
**Opposition: Gulf Health Hospitals, Inc. d/b/a Thomas Hospital; Thomas Medical Center; North Baldwin Infirmary; and Mobile Infirmary Association d/b/a Mobile Infirmary Medical Center d/b/a Infirmary Eastern Shore Ambulatory Surgical Center.**

**RV2018-021, ProHealth Hospice-Gadsden, LLC,** requests to merge CON 2506-HPC, Gadsden Regional Hospice to provide in-home hospice services and RV2011-029, Vitas Innovative Hospice Care of Fultondale to provide in-home hospice services, and to issue a revised CON authorizing ProHealth to provide in-home hospice services in Bibb, Blount, Calhoun, Cherokee, Chilton, Coosa, DeKalb, Etowah, Jefferson, Marshall, St. Clair, Shelby, Tuscaloosa, and Walker counties. Both were acquired by ProHealth through changes of ownership.

**RV2018-022, "The Treatment Centers Inc" d/b/a Gadsden Treatment Center,** requests to occupy a newly finished building located on the same property as the temporary building used due to a severe weather event that damaged the roof on the initial location. The distance between the newly finished building and the temporary building is approximately 40 feet. **Status: Non-Reviewable**
