- A. AL2018-034, Champion Sports Medicine-50051, Birmingham, AL:** Proposes to add outpatient occupational therapy services to the existing physical therapy service facility. **Opposition: None**
- B. AL2018-035, Seward Dialysis, LLC d/b/a Huntsville Metro Dialysis, Huntsville, AL:** Proposes to establish a new fourteen (14) station End Stage Renal Disease (“ESRD”) facility consisting of eleven (11) new in-center hemodialysis stations, one (1) hemodialysis isolation station, and two (2) home training stations, to be used alternatively for home hemodialysis and home peritoneal dialysis. **Opposition: The Health Care Authority of the City of Huntsville d/b/a Huntsville Hospital filed a letter opposing the project.**
- C. AL2018-036, Bio-Medical Applications of Alabama, Inc. d/b/a Fresenius Kidney Care Saraland, Saraland, AL:** Proposes to expand the existing End Stage Renal Disease Dialysis Treatment Center through the addition of four (4) in-center hemodialysis stations for a total of seventeen (17) in-center stations, one (1) of which is an isolation station. **Opposition: None**
- D. AL2018-038, Bio-Medical Applications of Alabama, Inc. d/b/a Fresenius Medical Care Forestdale, Birmingham, AL:** Proposes to add five (5) in-center hemodialysis stations to the existing End Stage Renal Disease (“ESRD”) Dialysis

Treatment Center and remove one (1) home training station, for a total of eighteen (18) in-center stations, one (1) of which will be an isolation station. The five (5) additional in-center stations are existing in-center stations that will be relocated from RCG-Southside, another ESRD facility in Jefferson County. **Opposition: None**

- E. **AL2018-039, DVA Healthcare Renal Care, Inc d/b/a Demopolis Dialysis, Demopolis, AL:** Proposes to relocate the existing facility within one mile of the current location and expand by adding six (6) in-center hemodialysis stations and one (1) isolation station for a total of twenty-two (22) licensed stations. **Opposition: None**
- F. **AL2018-041, Bio-Medical Applications of Alabama, Inc. d/b/a Fresenius Kidney Care Shelby, Alabaster, AL:** Proposes to relocate and expand its existing twelve (12) station ESRD Treatment Center to a nearby location and expand by adding twelve (12) in-center hemodialysis stations, for a total of twenty-four (24) in-center hemodialysis stations and change their trade name to Fresenius Kidney Care Shelby. **Opposition: None**
- G. **AL2018-044, Fresenius Medical Care Birmingham Home, LLC, d/b/a Fresenius Medical Care Birmingham Home, Birmingham, AL:** Proposes to expand its existing thirteen (13) station ESRD Dialysis Treatment Center through the addition of three (3) home training stations and one (1) in-center station, which will be relocated from RCG Southside, for a total of seventeen (17) stations. **Opposition: None**
- H. **AL2018-046, BBH BMC, LLC d/b/a Brookwood Baptist Medical Center, Birmingham, AL:** Proposes to design and construct two (2) new sixteen (16) bed intensive care units (ICU's), in two phases. Phase one will construct the new sixteen (16) bed Surgical Intensive Care Unit and Phase two will construct the new sixteen (16) bed Medical Intensive Care unit. **Opposition: None**
- I. **Reconsideration**
AL2018-005, Bay Eyes Surgery Center, Inc., Fairhope, AL: Proposes to add one (1) Class-C operating room to the existing two (2) Class-C operating rooms, convert space to a Class-C OR for a total of four (4) Class-C OR's and change the current designation as a single-specialty ambulatory surgery center to a multi-specialty ASC. This project was heard by Administrative Law Judge Mike Cole in a Contested Case Hearing. The ALJ approved the project.
Opposition: Gulf Health Hospitals, Inc. d/b/a Thomas Hospital; Thomas Medical Center; North Baldwin Infirmary; and Mobile Infirmary Association d/b/a Mobile Infirmary Medical Center d/b/a Infirmary Eastern Shore Ambulatory Surgical Center.
