The next four (4) projects were carried over from the November 17, 2021 meeting, which was canceled.

- A. AL2021-043, Ball HealthCare-West Mobile, LLC, Mobile, AL: Proposes to construct a seventy-five (75) bed skilled nursing facility, comprised of thirty-four (34) beds relocated from Spring Hill Manor Nursing Home and forty-one (41) beds relocated from Twin Oaks Rehabilitation & Healthcare, providing inpatient and outpatient rehabilitation services as part of a planned senior housing community. Opposition: None
- **B.** AL2021-047, Heritage Assisted Living and Memory Care, LLC, Madison, AL: Proposes to convert eight (8) existing licensed Assisted Living Facility (ALF) beds to Specialty Care Assisted Living Facility (SCALF) beds, adding them to the existing sixteen (16) SCALF beds already in service. **Opposition: None**
- C. AL2021-048, Affinity Hospital, LLC d/b/a Grandview Medical Center, Birmingham, AL: Proposes to expand the hospital's existing surgical services by adding four (4) operating rooms and two (2) procedure rooms. Opposition: None

#### **Contested Case:**

AL2021-022, ProHealth Home Health, LLC, Lee County: Proposes to establish a home health agency to provide home health services in Lee County. Opposition: Comfort Care Home Health Services, LLC (withdrawn 9/10/2021), Amedisys Home Health Care, Encompass Health Home Health, LHC Group, Inc., and Kindred at Home. ALJ assigned 5/25/2021. ALJ's filed Recommended Order granting the project to ProHealth Home Health on 10/28/2021. The Intervenors filed Exceptions to the ALJ's Recommended Order on 11/5/2021.

- D. AL2021-049, The Board of Trustees of the University of Alabama for the University of Alabama Hospital, in Birmingham, Jefferson County, AL: Proposes to replace its existing inpatient rehabilitation facility pursuant to Certificate of Need Rule 410-2-4-.14. This proposal will also include the replacement of major medical equipment. Opposition: None
- E. AL2021-050, Cottages Huntsville, LLC, Huntsville, AL: Proposes to convert thirty-two (32) licensed Assisted Living Facility (ALF) beds to thirty-two (32) Specialty Care Assisted Living Facility (SCALF) beds pursuant to the Statistical Update to Ala. Admin. Code r. 410-2-4-.04 of the 2020-2023 Alabama State Health Plan. Opposition: None
